- 依化工系博士班修讀辦法第三條第四款規定：學士及碩士學位均非化工本科者之博士班學生且未修習過輸送現象及單元操作(至少六學分)、化工熱力學與化學反應工程(至少各三學分)等課程者，應選修上述大學部課程或研究所高等輸送現象、高等化工熱力學、高等化工動力學課程共6學分，其中選修大學部課程之學分依規定經申請核准至多3學分可列入畢業學分。通過標準由系主任召集授課教師及相關教師開會審訂之。According to Article 3, Clause 4 of the Doctoral Program Regulations of the Department of Chemical Engineering: Doctoral students whose bachelor's and master's degrees are not in chemical engineering and who have not completed courses in transport phenomena and unit operations (at least 6 credits), chemical engineering thermodynamics, and chemical reaction engineering (at least 3 credits each) must take the relevant undergraduate courses or advanced graduate courses in transport phenomena, advanced chemical thermodynamics, and advanced chemical kinetics for a total of 6 credits. Among these, up to 3 credits from

undergraduate courses, upon approval, can be counted towards the graduation credits. The standards for this are set through a meeting convened by the department chair and relevant instructors.
